- For a chance to win, each swimmer must enter and complete a total of three swims, selecting any one swim from three different Events the Malabar Magic on February 16th 2025, the Coogee Island Challenge on April 13, 2025, and the South Maroubra Ocean Swim on 27th April 2025.
- Open to all individuals over 10 years of age
- Each Prize-winner must be present to claim their prize at the Prize Draw on April 27th during the South Maroubra Ocean Swim Prize Ceremony, or it will be redrawn.

Complete Terms & Conditions

- 1. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.
- 2. Promoter is South Maroubra Surf Club (ABN 20186 191094) of 1R Arthur Byrne Reserve Maroubra NSW 2035 ("Promoter").
- 3. The promotional period commences at 6.00 AM AEDT on the 16 February 2025 and ends at 11.59 AM AEDT on 27th April 2025 ("Promotional Period").
- 4. Entry is open to individuals who are over 10 years of age.

- c) either the 500m, 1km or 2km swim at South Maroubra on Sunday 27th April 2025 AND must be present at the time of the Prize Draw at 12 noon on Sunday 17th April 2025 at the South Maroubra Surf Life Saving Club, part of the prize giving ceremony.
- 6. Each winner will be picked at random by a representative(s) of the Promoter on 27th April 2025 at 12 noon, within the prize giving ceremony of the South Maroubra Ocean Swim 2025, at the South Maroubra Surf Life Saving Club. Each winner must be present for the prize draw to claim the prize.
- 7. If any prize winner is not present to claim the prize when the prize is drawn at South Maroubra Surf Life Saving Club at 12 noon on April 27th 2025, then such prize will be forfeited, and an alternate winner will be selected from all remaining (non-winning) eligible entries immediately.
